### METHOD OF APPOINTMENT

2. The method of appointment to the posts shall be as under:—

(Provided that the incumbents presently working in Customs, Income Tax, Engineering and Female Immigration Officers shall be merged along-with posts they are occupying, in 'Investigation Group' against the posts of equivalent scale/grade):

Provided further that if no suitable person is available for promotion, the post or posts reserved for promotion shall be filled by initial appointment and failing that by transfer.

### CONDITIONS FOR PROMOTION

3. Promotion to posts in column (2) below shall be made by selection from amongst the person who hold the posts specified in column (3) on a regular basis and fulfill the conditions prescribed in column (4).

**QUALIFICATION, EXPERIENCE AND AGE LIMIT FOR INITIAL APPOINTMENT**

4. On the closing date for receipt of applications as fixed relevant advertisement, a candidate for initial appointment to a post must the educational qualifications and experience and must be within the age mentioned against the post concerned in the Schedule to this notification:

Provided that the maximum age limit shall be relaxed in respect candidates specified, and to the extent indicated, in the Initial Appointment Civil Posts (Relaxation of Upper Age Limit) Rules, 1993, as amended from time to time.

5. Appointment by transfer shall be made in accordance with provisions of Rule-7 and 9 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.

**PROBATION**

6. Persons appointed by promotion or initial appointment or shall be on probation in accordance with the provision of Section 6 of Civil Servants Act, 1973 read with Rule 21 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.
