

The Federal Investigation Agency, Karachi Zone (Ministry of Interior & Narcotics Control) invites E-bids from eligible Bidders on single stage – single envelope procedure for procurement of other miscellaneous, stationary and repair of furniture & fixtures described in the bidding documents on EPADS v2.0.
2. All Bids must be accompanied by a Bid Security @ 5% of the quoted amount in Bid Security Section in Bidding Document in the form of Pay Order.
3. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>.
4. All bids must be accompanied by a earnest money (5%) of total bid amount, and must be delivered to the office of the Director, FIA Sindh, 25-A, Lalazar, M.T, Khan Road, Karachi or before 1500 hours on 08.04.2026. The bids will be publicly opened in the office of the Director, FIA Sindh, 25-A, Lalazar, M.T, Khan Road, Karachi at 1530 hours on the same day in presence of bidders who wish to remain present. Bidder(s) are required to get themselves registered on EPADS v2.0. E-bids will be opened using EPADS v2.0 on the same day at 08.04.2026 15:30 PM. Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://vendors.epads.gov.pk/>.
5. Original Instruments i.e. tender fees pay order and bid security pay order must reached before 15:00 hours on 08.04.2026 otherwise bid will not be entertained.
6. Bidders shall submit bids, which comply with the bidding documents, for alternate bids bidder has to purchase separate bidding documents and alternate bid shall be treated as separate bid.
7. Competent authority can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule.
8. All prices quoted must include any Taxes applicable, i.e. Income Tax, Sales Tax or any other tax imposed by government by law. If not specifically mentioned in the Quotation, then it will be presumed that the prices include all the taxes.
